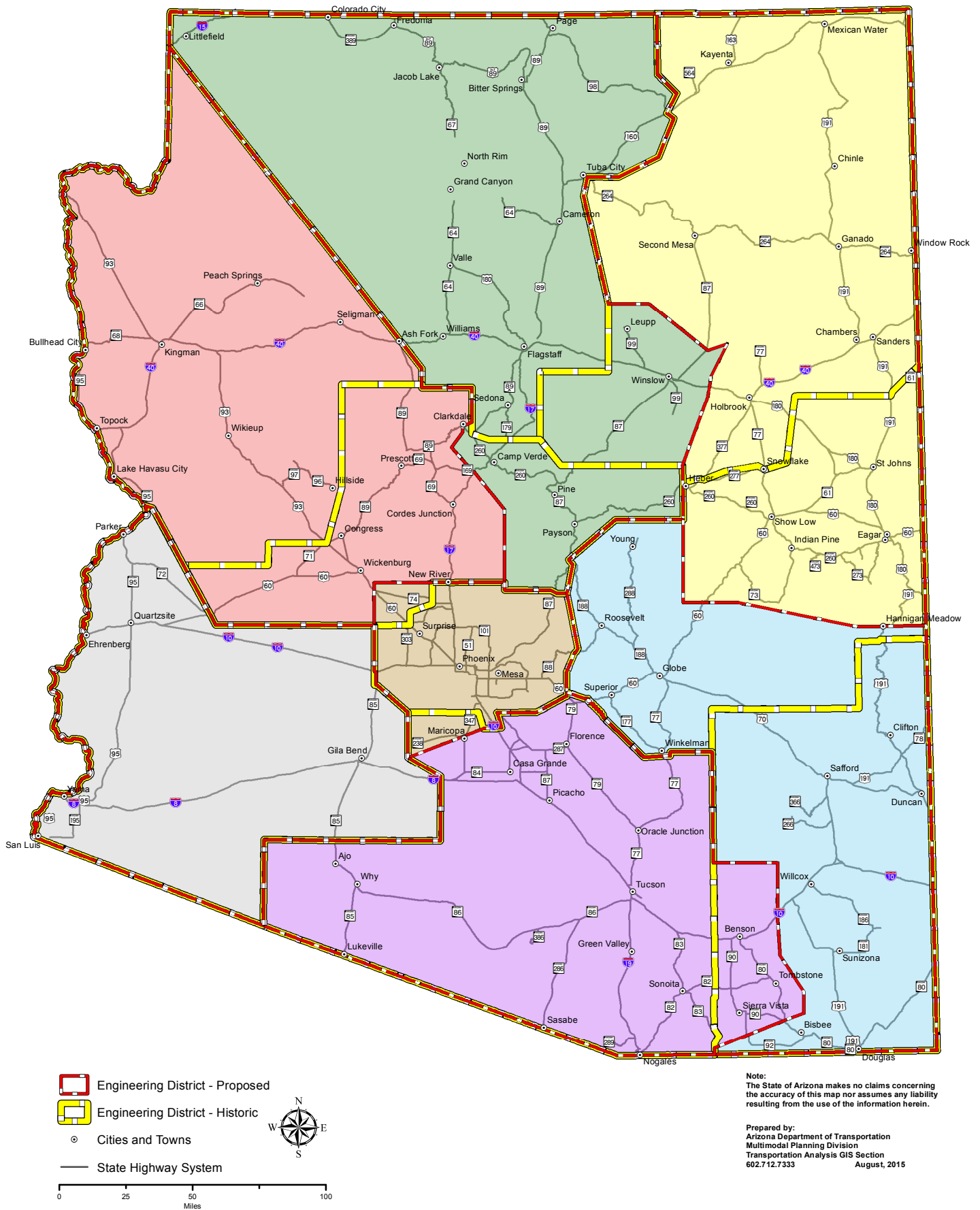

The City of Eloy and Sun Corridor MPO staff met with ADOT on September 24, 2015 to discuss all possible options for cancelling this project. Because this project is currently in the Initial Design Concept Report (IDCR) phase, it is hoped that the City will not have to pay back any federal funds that has been expended thus far. FHWA will make the final determination.

ELO13-01D Design Phase – To-date approximately \$138,000 has been spent by the consultant on the IDCR. Therefore, once this project is de-obligated by ADOT/FHWA approximately \$333,000 of STP funding will be coming back to the Sun Corridor MPO 2016 ledger.

Currently, the MPO does not have any FY2016 planned design or construction projects; therefore, the MPO recommends that a loan be made to the Maricopa Association of Governments (MAG) in the amount of approximately \$333,000, with a payback in FY 2017.

5304 Transit Funding – On September 8, 2015 the EB approved MPO staff to apply for the 5304 Transit funding to fund the Transit Study in the amount of \$100,000, but not to exceed \$200,000. The local match/in-kind is 20%.

The NOFA was sent out by ADOT on September 29, 2015 and the Grant application is due to ADOT by December 4, 2015. Awards will be announced in February, 2016.

Since there is only \$1M available for the 5304 grant program statewide, additional funding may be needed to pay for the MPO Transit Plan. 5303/5305 Transit funding can be utilized to supplement the cost for the MPO Transit Plan.

5303/5305 Transit Funding - The Sun Corridor MPO currently has a balance of approximately \$120,000 of 5303/5305 Transit funding that has not been spent by the MPO.

Approximately \$100,000 or less of 5303/5305 Transit funding could be utilized to supplement the MPO Transit Plan. The actual amount needed will depend on if the MPO is awarded 5304 funding. The local match/in-kind is 20%.

The Sun Corridor MPO Staff recommends approval to utilize the 5303/5305 Transit Funding in the amount of \$50,000 to \$100,000 to supplement the MPO Transit Plan.
