	<p><i>Duane Eitel provided the following update:</i></p> <p>SCMPO Traffic Count Project - The Consultant is currently working on creating GIS and PDF maps for the count locations. This effort is anticipated to be completed by mid-June. Jason Hafner will send a link out to the Traffic Counts to the Executive Board.</p> <p>SCMPO TAC Bylaws Amendment - This effort is completed and was approved by the Board at the March 9, 2021 meeting.</p> <p>HSIP Funding to Hire Consultant - In anticipation of an upcoming HSIP Call for Projects, the TAC has directed SCMPO staff to utilize \$46k of HSIP funds to hire a Consultant to help member agencies identify projects and fill out applications to compete for the HSIP funds.</p> <p>RTAC Project List - RTAC is planning on requesting \$40 million of earmark funding for Greater Arizona transportation projects at the next Legislative Session, of that \$3,459,274 would come to the Sun Corridor MPO Region. The TAC determined that the SCMPO allocation of funds would be equally distributed to the member agencies (\$864,818.50 each). Local contributions on projects could help sell the idea to some Legislators, so it may be a good idea to choose projects that are not fully funded by the allocation. Project lists are due back to the MPO by May 31, 2021 so that they can receive TAC approval on June 9, 2021 and Executive Board approval on July 13, 2021. Irene Higgs stated that the TAC has been instructed to work with their SCMPO Board representative to determine the best use of those funds for each agency</p>

The TAC will vote to recommend approval of the New Finding of Conformity on June 10, 2021 and with Executive Board approval on June 15, 2021.</p> <p>Winter 2021 AQ Conformity Analysis - The project update list will go out to all member agencies as soon as staff receives the required dates from MAG. The list will be due back to SCMPO on June 9, 2021. Approval to move forward with the Public Review and Comment Period will be on the September 2021 Board Agenda. Approval of the New Finding of Conformity and associated TIP Amendment will be on the November 2021 Board Agenda. 9	Federal Highways Administration (FHWA) Update (Information Only)
	<p><i>Ed Stillings provided the following update:</i></p> <p>RAISE Grant - 2021 RAISE Transportation Discretionary Grant program (RAISE Grants). Formerly known as TIGER, then BUILD, the 2021 RAISE Grant program will award \$1B to applicants on a competitive basis for planning and capital projects that have a significant local or regional impact. The maximum grant award for this round of RAISE grants is \$25M, with no more than \$100M awarded to a single State. Up to \$30M will be awarded for planning grants, including at least \$10M for Areas of Persistent Poverty. Applications are to be submitted through Grants.gov by July 12, 2021 at 5:00 PM EDT.</p> <p><i>Irene Higgs stated that MPO Staff met with FHWA, FTA, and ADOT to review the DRAFT SCMPO 2022 and 2023 UPWP. All recommended changes have been incorporated into the final UPWP and is on the Consent Agenda for Board approval. The UPWP is due to ADOT by May 22, 2021.</i></p>

One element of the application is a request for funds to help purchase a new bus for Cotton Express. Cotton Express provides Deviated Fixed Route and On Demand service throughout the City of Coolidge. If approved, the new bus would replace a 2009 model that has approximately 240,000 miles.

The second part of the application is a request for funds to help pay for a security system upgrade to the Coolidge Transit Center. The system was installed 12 years ago and will likely fail if not replaced soon. The new system would upgrade cameras, the DVR system and door readers and would essentially revamp the entire security system.

On behalf of the Sun Corridor Metropolitan Planning Organization (MPO), I strongly support the Peters Road Widening project submitted by the City of Casa Grande, Arizona. In this application, the City is seeking federal funds to help pay for this highly important Regional roadway project that will help with current manufacturing developments as well as entice future economic development into the Region.

The Peters Road Widening project will add an additional thru lane in each direction and a center turn lane from Burris Road to Thornton Road. The widening of this roadway will provide appropriate access and connectivity for existing and imminent Economic Development projects and for the citizens of the Region. Currently, the roadway is a two-lane facility that is inadequate to provide the access and service levels needed to serve existing facilities such as Lucid Motors and Tractor Supply. Tractor supply currently employs approximately 400 people and Lucid motors is targeting 3,000 employees by the end of the year and estimating 7,000 at full build out.


Peters Road also serves the Central Arizona Commerce Park (CAZCP). Currently, there are several manufacturing developments under construction and two additional significant Economic Development projects in the final evaluation of a selection of the CAZCP for siting of projects. With the amount of existing traffic plus the likely increases for Peters Road, the roadway must be widened to provide sufficient access and service for the success of these projects.

The west end of the Peters Road Widening project provides connectivity to Burris Road. Burris is currently within the City's Industrial Development corridor and several Economic Development projects have evaluated or are in the process of evaluation of these sites. The Peters Road Widening project would provide connectivity from these sites to Thornton Road which provides direct and easy access to Interstate 8.

This project is necessary to provide much-needed accessibility and service for landing and serving the significant number of Industrial users and the City's Industrial Corridor's potential development. These industrial users will provide needed jobs for both the City of Casa Grande and the region.

SUBJECT: Discussion and Possible Action to Approve an Amendment to the FY2022-2023 UPWP, Solicit Consultant, and Award Contract for Crash Data Analysis/HSIP Application Project

It is expected that on July 1, 2021, ADOT will announce a formal HSIP Call for Projects for State Fiscal Years 2025 and 2026. Applications are anticipated to be due by **November 1, 2021**.

The call for projects is in support of the Transportation Performance Management and the Arizona Strategic Highway Safety Plan. The call for projects will likely focus on reducing fatalities and serious injuries on all public roads; and all projects submitted will compete for statewide HSIP funds.

- Amounts are unknown at this time, but \$35,000,000 of HSIP funds was made available in FY23 and \$35,000,000 in FY24.
- In past years, total project costs for non-infrastructure projects, e.g., SHSPs, RSAs, licensing fees, etc. were capped at 5% of the yearly SFY HSIP available funds.
- Since HSIP funds became a competitive process, Sun Corridor member agencies have been awarded \$14,952,346 for safety projects in Pinal County.
- Of that, \$7,858,598 was awarded for projects within the Sun Corridor MPO boundaries.

The Scope of Work for this project is to:

- Crash Data Analysis
- Coordination with Local Agencies, SCMPO and ADOT for application submittal by hard deadline.
- Identify areas of need within the Sun Corridor MPO boundaries.
- Identify appropriate countermeasures for the identified areas of need.

- Complete competitive HSIP applications for the Sun Corridor MPO Region. Applications will need to include crash history, cost estimates, project descriptions, CMFs, BC Ratio, etc.

The anticipated cost for this project is \$46,709 of STBG funds.

The proposed procurement timeline is based on the currently known information about the CYMPO On-Call process and the HSIP Call for Projects. All rules and guidelines required by these processes will be followed by Sun Corridor MPO staff. Dates marked with asterisks (**) are subject to change as more information becomes available.

SUBJECT: Discussion and Possible Action to Approve a Surface Transportation Block Grant (STBG) Funding Loan

Regional Funding – ADOT Financial Management Section has tentatively agreed to advance Sun Corridor MPO \$1,350,000 of STBG Program funds in State Fiscal Year 2023. In exchange Sun Corridor MPO will pay ADOT \$675,000 of STBG Program funds in State Fiscal Year 2024 and \$675,000 of STBG Program funds in State Fiscal Year 2025.

The City of Coolidge has the following projects programmed in the Sun Corridor MPO TIP:

Coolidge Ave; 9th St – Skousen Rd

- Design FY22 \$144,000 HURF Exchange
- Construction FY24 \$607,500 HURF Exchange

Vah Ki Inn Rd; 9th St – Kenworthy Rd

- Design FY23 \$144,000 HURF Exchange
- Construction FY25 \$607,500 HURF Exchange

If approved, this loan would allow the City of Coolidge to utilize the funds to combine the two projects into one project and advance the construction of both into FY23. Completing the loan has two main benefits. First, the loan allows for the combination of the two projects, likely resulting in cost saving of both the design and construction of the project. Secondly, the loan would allow for construction advancement thereby completing the roadway improvements one year early for Coolidge Avenue and two years early for Vah Ki Inn Road.

The Sun Corridor MPO staff recommends that a loan be approved between Sun Corridor MPO and ADOT for FY23 STBG funds.

Approved transfer/loan requests must be received by June 15th each year; allow two weeks for approval. Transfers generally will appear on the next ledger, depending on the date of receipt.

This request will be processed based on the amount of apportionments and obligation authority available to the loaning/transferring agency at the time of receipt, which may be different than the amount shown on the most recent ledger. Loans are to be repaid; transfers will not be repaid.

Loans of apportionments and/or obligation authority to ADOT- these loans are not guaranteed; are capped at a total, maximum of \$10 million annually; are limited to greater Arizona STP projects in a TIP which exceed the region's available STP allocation; will be on a first come, first served basis if available; require advance approval. Every effort should be made to reprogram federal funds on projects ready to authorize by June 30th annually or to loan to other regional entities before approaching ADOT about a loan. Loans to ADOT must be approved and executed by March 31st annually.

SUBJECT: Discussion and Possible Action to Approve the Regional Transportation Advocacy Council (RTAC) Regional Project List for the Sun Corridor MPO Region

The Regional Transportation Advocacy Council (RTAC) has identified project earmarking as a viable option for securing infrastructure funding from the state legislature. Therefore, RTAC is proposing a hybrid approach whereby the regional planning agencies of Greater Arizona each determine a list of prioritized projects. These individual lists would then be consolidated and presented to the State legislature at the next legislative session. This allows the legislators the opportunity to continue advocating for specific projects but listed projects would reflect regional priorities of Greater Arizona.

The RTAC Management Committee settled on a \$50 million ask for the total project list. It was determined that funding allocation would be proportional to population. Based on this decision the currently proposed Sun Corridor MPO amount is **\$3,574,668**. It should be noted that these would be State funds, and therefore would not come with a local match requirement and would not have the same restrictions as many Federal fund sources. This effort does not preclude any local jurisdiction from pursuing separate earmarks for other regionally significant projects.

The Sun Corridor MPO Staff recommends approval of the Regional Transportation Advocacy Council (RTAC) Regional Project List for the Sun Corridor MPO Region.
