Have received no comments to date. • The 30-day public review and comment period is tentatively scheduled for November 8, 2022, through December 8, 2022. <i>Mike Sundblom provided the following update:</i> Pinal County Air Quality sent out the preliminary draft West Pinal PM10 nonattainment area general fugitive dust rules to stakeholders on August 22, 2022. Pinal County Air Quality would like stakeholders to review and provide comments and questions back. Dust rules and is subject to change, pending feedback from stakeholders and the Environmental Protection Agency (EPA).
